

General Information

SCOPE OF EXHIBIT

- All 2D visual art forms are eligible.
- Length of exhibit - up to 2 (two) months.
- Artist limited to 1 (one) show per year.
- Artist must supply a sufficient number of pieces for attractive gallery exhibit.

SELECTION PROCESS

- Submission of completed application.
- Review by City of Milpitas Arts Commission and staff.

SALE OF ART

- Pieces must be labeled with business size cards (3.5"x2") noting the title of the work and the selling price or indication that the piece is not for sale (NFS).
- All sales will be conducted by the artist.
- If provided, artist business cards will be given to interested buyers by City staff.
- Artwork that is sold must remain in the gallery for the duration of the show.

INSTALLATION

- All artwork will be installed by the artist with staff supervision.
- Date of installation will be arranged by staff with the artist.
- Supplies, accessories and equipment needed to display artwork are the responsibility of the artist.
- City staff and a representative of the Arts Commission will preview the exhibit artwork prior to opening the show.

PUBLICITY

- Limited publicity will be provided in City publications and by other information distributed by Recreation Services (i.e.: website, email or Cable Channel 15).

OPENING RECEPTION

- An opening reception may be held for each show.
- The artist must attend the opening reception.

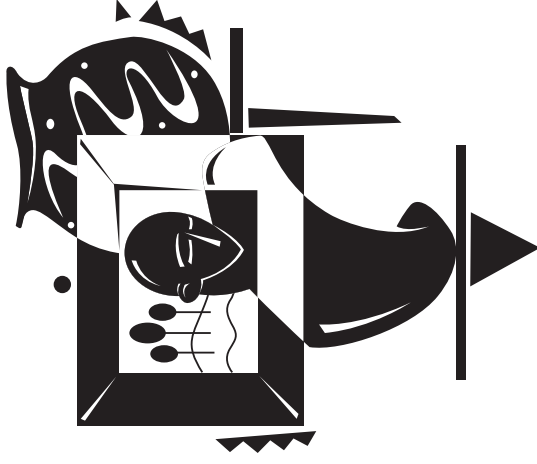
INSURANCE
