SUBJECT: Approve the Ten-Year Capital Maintenance Plan

RECOMMENDED ACTIONS

Approve the Ten-Year Capital Maintenance Plan to include the Technology Improvements.

BACKGROUND/REASONS FOR RECOMMENDATION

On October 24, 2013, the Board approved the establishment of a Ten-Year Capital Maintenance Plan ("CMP") and an associated financial reserve. The CMP includes all capital maintenance related to projects in excess of \$25,000 that are anticipated over the next ten years. The designated reserve differs from regular, annual maintenance projects that are included in the annual operating budget, including, but not limited to HVAC maintenance, plumbing, electrical, elevator maintenance, carpet and upholstery cleaning, pest management, window and door repair, fire sprinkler testing and maintenance, roofing inspections and repairs, alarm system monitoring and repairs. The CMP does not constitute an approval to expend funds; instead, this plan provides the basis for the establishment of a Capital Maintenance Reserve based on estimated needs throughout the district. Actual approval for expenditures of these reserved funds occurs during the review and acceptance of the annual operating budget in April and June.

Formerly, the Technology Replacement and Improvement Plan was a separate informational only report presented in January. The three-year Technology Replacement and Improvement plan is set to conclude in June of 2025, therefore the future Technology Improvements which include technological upgrades to the libraries, business IT systems and security and large technology special projects will be included in the CMP.

FISCAL IMPLICATIONS

The proposed Capital Maintenance Plan will guide the required designation of reserves request which will be presented within the Proposed Budget for the Board's action in April.
